About the scheme

We are offering a total of 45 unpaid work experience placements which will be held between June and August 2022 for MPharm undergraduate students. These will be for a 4 week duration where you will be based at one of our sites. It is important when you complete the application form that you specify which sites you will be able to travel to for the duration of the placement as well as your availability for the months of June, July and August.

The successful applicant will be allocated to one of our teams who will oversee the placement and as well as a supervisor who will support you during your time with us. The aim of these placements are to provide an in-depth insight in to hospital pharmacy and the diverse range of roles for pharmacists and the wider pharmacy team.

A key focus of the placement will involve contribution to project work such as clinical audit, service evaluation or quality improvement as well as opportunities to visit a number of areas across the pharmacy department. This would include visits to a number of our in-patient wards and shadowing our specialist pharmacists in out-patient clinics as examples.

Our established programme comes highly recommended with several of our summer students returning each year as Trainee (formally Pre-Registration) Pharmacists. A number of students have also had their work taken forwards and showcased locally and regionally.

Due to the ongoing pandemic some placements may involve virtual or a blended mix of virtual/on-site involvement. A small number of placements will be cross-site and hospital transport is normally available. Confirmation of the exact nature of the placements will be confirmed prior to the proposed start dates.

Applying for a placement

Applications are considered on merit and there will not be any interviews or selection tests. We only accept pharmacy summer placement application forms and these will form the basis of any offers. We **will not consider** blank or part-filled applications with a CV attached.

To help us plan and allocate tutors it is important that you clearly state which month you will be available for your summer placement experience as well as which sites you would be able to work at.

As we receive a large number of applications, we are unable to contact everyone individually. If you do not receive a reply from us **4 weeks after the deadline has passed**, please assume that you have been unsuccessful.

Any applications received before or after this time window will **not** be considered.

These voluntary placements are only open to **UK pharmacy undergraduates** (i.e. students currently studying for an MPharm, or equivalent, degree programme).
